**Waiver and Release of Liability**

In consideration of **PORT PROVIDENCE PADDLE** furnishing services and/or equipment to enable me to participate in water sports activities, I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have (a) inherent risks, dangers and hazards and such exists in my use of water sports equipment and my participation in water sports activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **PORT PROVIDENCE PADDLE**, the negligence of the participants, the negligence of others, accidents breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including but not limited to guide decision making, including that the guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out or drowning while in the raft, canoe, or kayak and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; and (d) by participating in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages whether causes in whole or in part by the negligence of other conduct of the owners, agents, officers, or employees of **PORT PROVIDENCE PADDLE** or by any other person.

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify **PORT PROVIDENCE PADDLE** and its owners, agents, officers and employees from any and all claims, actions, or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of watersports equipments or my participation in water sports activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of **PORT PROVIDENCE PADDLE**.

**I have read the above Waiver and Release and by signing it agree, it is my intention to exempt and relieve PORT PROVIDENCE PADDLE from liability for personal injury, property damage or wrongful death caused by negligence or any other cause.**
